By signing this form, the applicant, owner, and excavator all acknowledge and certify that they are familiar with, or, before commencement of the work, will become familiar with, all laws and regulations applicable to work proposed, including OSHA regulations, G.L. C. 82A, 520 CMR 7.00 et seq., and any applicable Town of Barnstable ordinances, by-laws and regulations and they covenant and agree that all work done under the permit issued for such work will comply therewith in all respects and with the conditions set forth below.

The undersigned owner authorizes the applicant to apply for the permit and the excavator to undertake such work on the property of the owner, and also, for the duration of construction, authorizes persons duly appointed by the Town of Barnstable to enter upon the property to monitor and inspect the work for conformity with the conditions attached hereto and the laws and regulations governing such work.

The undersigned applicant, owner and excavator agree jointly and severally to reimburse the Town of Barnstable for any and all costs and expenses incurred by the Town of Barnstable in connection with this permit and the work conducted thereunder, including but not limited to enforcing the requirements of state law and conditions of this permit, inspections made to assure compliance therewith, and measures taken by the Town of Barnstable to protect the public where the applicant owner or excavator has failed to comply therewith including police details and other remedial measures deemed necessary by the Town of Barnstable.

The undersigned applicant, owner and excavator agree jointly and severally to defend, indemnify, and hold harmless the Town of Barnstable and all of its agents and employees from any and all liability, causes or action, costs, and expenses resulting from or arising out of any injury, death, loss, or damage to any person or property during the work conducted under this permit.

The Department of Public Works must be notified at least 24 hours in advance of scheduled trench compaction, and/or repaving. Cutting of pavement is prohibited at all times unless prior approval is given by this permit application. Newly paved roads have a five (5) year moratorium for cutting of pavement and permits will not be granted unless the need for cutting is proven to be a necessity for emergency repairs.
