If you would like to purchase your sticker through the mail, please complete the following steps. .

## **Instructions:**

- 1. Return completed and SIGNED application form.
- 2. Enclose a copy of the current registration for each vehicle for which a sticker is being purchased. If your vehicle is not registered in Barnstable or is registered to a post office box, you MUST provide a copy of a valid real estate tax bill, deed or rental agreement showing your name linked to your Barnstable address with a copy of your current vehicle registration.
- 3. If your vehicle is leased, a copy of the page in your lease agreement where your name is linked to this vehicle, a copy of current vehicle registration and proof of residency as described in instruction #2.
- 4. If your vehicle is registered to a business, please include documentation linking you to the business (business card, pay stub, etc.), a copy of current registration and proof of residency as described in instruction #2.
- 5. A check or money order made payable to the Town of Barnstable for **\$250.00** for the first sticker. An additional sticker is **\$25.00**. Do not mail cash.
- 6. Two stickers are allowed per dwelling unit.
- 7. Send all required documentation listed above and the signed application acknowledging that you agree to our rules and regulations along with a self-addressed stamped envelope to:

## Rules and Regulations for the Barnstable Transfer Station

- 1. Stickers expire June 30, 2019.
- 2. Stickers go on sale May 1<sup>st</sup> 2018 for the next sticker year, July 1, 2018-June 30, 2019.
- 3 Stickers are NON-TRANSFERABLE and can not be placed on any vehicle except the one it was purchased for. There are NO EXCEPTIONS.
- 4. A replacement sticker will be issued with the return of the old sticker or documented proof, approved by the Division Supervisor, that the old sticker has been destroyed. Please refer to the Fee Schedule for associated fees.
- 5. The sticker must be PERMANENTLY AFFIXED on the inside lower left corner of your windshield. STICKERS PLACED IN PLASTIC WILL BE CONSIDERED INVALID.
- 6. Failure to abide by these rules may result in your Transfer Station privileges suspended. Please detach below and mail application and all needed documentation to address shown above.
